OLD BUSINESS

A Public Employer Health Emergency Plan has been created for the Town of Reading utilizing input from Town Atty, Tom Bowes, and Perma. This plan was presented to the Town Board members. Governor Cuomo signed legislation requiring all public employers to create a Public Employer Health Emergency Plan to protect employees and contractors in the event of another public health emergency declaration in NYS. Plans must be finalized by April 1, 2021. The Town Board will review the plan and vote on it at the March 10, 2021 board meeting.

The sewer meters on Reading Road and Co. Rd. 30 have been calibrated and installation will finally be completed in March.

Sexual harassment and Gender Identity Training materials have been distributed to the Town Board members and all Town Employees. The training will be held in March.

New computer monitors with cameras have been installed in Town Clerk, Supervisor, and Highway Superintendent offices so they can utilize zoom meetings.

Supervisor Miller has received a letter of resignation from Ross Spallone, Building Inspector III, Ross Spallone has accepted a position in Texas where he and his wife are relocating.
