There was an incident of garbage dumping on Spencer Road. The Highway Dept. picked up and disposed of the garbage at Cardinal Disposal at a cost of \$25. The DEC has investigated and offender was fined \$500.

It has come to our attention that the leash law from 2010 was not reported to the State of NY. It will be revised and a new local law created. Waiting for response from Atty, T. Bowes, to draft a revision to be presented to the Town Board.

Justice John Norman provided information to perform the annual Justice Audit. The audit will be performed on February 9 at 7pm by P. Gill and C. Stamp.

Covid Relief report is due by March 31, 2022 regarding how we are allocating funds. Supervisor S. Miller asked if we should utilize it for employees who have exceeded their sick time due to pandemic related illness?
