VISITOR'S COMMENTS:

Mark Rondinaro, Schuyler County Legislature, provided October Sales Tax Information. October Sales Tax Revenue was \$797,708 for an increase of \$168,658 or 21.14%. from 2021. Our YTD Sales Revenue is up \$602,294 from 2021 or 5.33%.

Alice Conklin, RSVP Volunteer-Insurance Coordinator, expressed her concern about the Schuyler County Legislature contracting with Cayuga Health Systems for a new ambulance service in the County. The Elderly will be the most affected by this new contract as several supplemental insurance options available to them are out of the Network of Cayuga Medical and therefore they will be the most negatively affected by this new contract.

Steve Williams, VP of the Schuyler County Volunteer Ambulance spoke of the new contract and how it will negatively affect the Volunteer Ambulance. They will be losing much needed income from losing transport and ambulance services. He disputed the negative publicity the Schuyler County Volunteer Ambulance has received regarding slow response time. They will continue to service the Town of Reading, Dix, and some of Hector and plan on sticking around.

OLD BUSINESS

Supervisor, S. Miller, has signed the contract with Hale Roofing per approval of the Town Board. They would like 50% down payment at start of project and 50% at completion.

The Town Board is continuing to work on adopting a Local Law to include part 1203 of article 19 of the NYS Compilation of codes, rules and requirements. (NYCCRR). Upon further discussion with Town Attorney, Guy Krogh, it is not a revision of Local Law #2 of 2007, but rather a new local law will need to be drafted and a public hearing will need to be held. This cannot possibly be done by the NYS requested deadline of December 31, 2022.

Village of Dundee has sent us information detailing the cost per child of utilizing the Summer Youth Program. The cost for the Town of Reading would be \$18.11 per child attending residing in the Town of Reading, but in the Dundee School District. We have \$500 budgeted for Youth Programs in 2023.

It is recommended that the Townships allow a 3rd party vendor to fold, stuff and mail tax bills to residents using a bulk mailing postage rate. Many questions were asked by the Town Clerks regarding cost of paper and envelopes, and additional information that can be added to the Tax Bills. The Towns will not be charged additionally to have the vendor print, fold and stuff tax bills. The only cost for us will be for the postage. It is recommended that Townships take advantage of this cost savings.
