## **VISITOR'S COMMENTS:**

Mark Rondinaro, Schuyler County Legislature, provided sales tax information. Sales tax growth is very impressive. September sales tax payment for 2021 was up by 31.51 % or approx. \$800,000 from 2020 during Covid shutdowns. Overall, the sales tax is up by almost 28% or \$1.02 Million from 2020.

### **OLD BUSINESS**

Supervisor Miller has contacted the NYS Assoc. of Towns to seek their input on allocating Federal Covid Relief funds we received.

#### **NEW BUSINESS:**

Supervisor Miller has written a response to Michael Stamp of EC Cooper Insurance regarding the necessity of having 2 signatures on checks. Supervisor Miller has assured the Insurance agent that the security of our accounts is sound. The Town Clerk's office does require a 2<sup>nd</sup> signature on checks written over \$500 from the Town Clerk and Tax Accounts. The timeliness of requiring a second signature from the Deputy Supervisor on payroll checks and checks written out of the other Town checking accounts would be difficult

Supervisor Miller has reviewed the Fiscal Stress Scores provided by the State Comptroller office Our Financial Stress Score has remained unchanged at 0.0 for the last 3 years. Our Environmental Stress Score was 16.7 in 2018, 16.7 in 2019, and was 20.0 in 2020.

The Town Board has reviewed the 2021 Preliminary Budget
