TOWN OF READING BOARD MEETING September 13, 2023

VISITORS:

Mark Rondinaro – Schuyler County Legislature Chad Hendrickson -HSSC

The meeting was called to order at 7:30 pm with the reciting of the Pledge of Allegiance.

VISITOR'S COMMENTS:

Mark Rondinaro, Schuyler County Legislature, provided YTD. Sales Tax Information. YTD Sales Tax Revenue including the August payments was \$8,472,711 for an increase of \$1,220,677 or 16.83%. The August payment sales were up significantly due to a big sales adjustment in August of 2022. It appears to be an increase of \$577,334 or 63.28% from 2022, but in reality, it was probably only 12 or 13%

Chad Hendrickson on behalf of the HSSC (Humane Society of Schuyler Co.) came to the meeting to talk about the possibility of paying HSSC an annual sum of \$4,000 instead of sending dog license fees collected monthly. Currently we send the HSSC 70% of dog license fees collected and Ag and Markets receives \$1 for each spayed/neutered dog or \$3 for each unspayed/unneutered dog. This "pre-payment" will help with them to budget their funds better and also help them financially. On average the Town Clerk sends HSSC approx. \$190 a month for dog license fees collected. The average yearly payments to HSSC are \$2200. If the Town Board agrees, then Supervisor Miller would issue a check to them in January and Town Clerk Alger would give the allotted monthly payment to Supervisor Miller as part of General/Part town funds.
