Nowel and Naaman Faus submitted a Site Plan Application for the relocation of their business Lakeside Tractor currently located on the Reading Road in the Town of Starkey to State Route 14A near the ReDun airstrip (Tax Map No. 31.00-4-8). The parcel is 138.45 acres and they would like to erect a 64 x 68' pole barn to be used primarily for tractor repair and sales of new and used tractor parts. They plan to have a gravel driveway and will not adding a septic or well at the present time. They will be utilizing Portable Potties and will have potable water on site. It was recommended that they also have an eye wash station.
