OLD BUSINESS

The Request for Proposals to hire an engineering firm to begin the process of an engineering study for newly proposed water district in the Town of Reading has been published in the Elmira Star

Gazette and also placed on the NYS Contract Reporter Bulleting Board. Supervisor Miller has already received some responses. The time period to submit bids is from the publish date of September 9 to October 9th at noon. Sealed bids will be opened at the October 9th Board meeting.

Atty. G. Krogh has returned a redline copy of the Short -Term Rental Law to be reviewed at the Planning Board meeting on September 18, 2024.

Atty. G. Krogh is working on a revised local law to give the Code Enforcement Officer more jurisdiction in enforcement of the NYS Codes concerning abandoned property and cleanup of properties.

Anthony from SCT was here for most of a day to work on migrating the Haefele email over to the townofreadingny.org emails using Microsoft Outlook. There still are a few bugs to work out to make sure all email is being forwarded from our old Haefele email account.

Both Judicial review disputing assessments are being responded to by legal counsel, S. Chaulifoux.

It was recommended by Bookkeeper, H. Ribble, that we pay an average monthly mileage payment to D. Tremblay, Code Enforcement Officer, to make it easier on him. H. Ribble took an average from last years mileage to calculate the monthly amount of \$190.

Code Enforcement Officer Tremblay would like to try a different software package. The current IWORQ's program isn't really meeting his needs like he had hoped. The Town Board would like some pricing comparisons to the proposed Cloud Permit program vs. IWORQ.
