#### NEW BUSINESS:

The Town Board has reviewed the Annual Equipment and Fleet Inventory submitted by Highway Superintendent, J. Switzer, as requested by Schuyler County Highway Dept.

Since July the Schuyler County Towns Supervisors have been trying to reach an agreement with the HSSC for a reasonable contract for 2025. They are basing their contract amounts based on a % of dogs taken in from each Township in 2023. The HSSC reports indicate that 9 dogs were taken in by Animal Control from the Town of Reading in 2023. Of the 9 dogs, 1 dog was in the Town of Tyrone, 2 dogs were "strays" and at the shelter, and 6 dogs were redeemed by the owners. We paid them \$3,500 in 2023. The initial contract, dated June 27, 2024, indicated they would like us to pay them \$11,834 in 2025 with a 5% annual increase. During negotiation with the Townships and the County they increased the amount to around \$14,000. The Town Board suggested we be generous and budget \$5,000 for the HSSC, but they were unwilling to accept that amount.

We have received 2 proposals from the Southern Tier Animal Control. One contract was a full contract that included Animal Control Officer duties and the other contract was per dog at large. Per much discussion with other Town Supervisors and in consideration of the Schuyler County Animal Control Officer's position, Supervisor Miller recommends that we sign the \$175 per dog contract rather than pay the HSSC the unfounded amount they are requesting for 2025.

C. Stamp made a motion to grant permission for Supervisor Miller to sign the Southern Tier Animal Control per dog contract. Seconded by P. Gill
